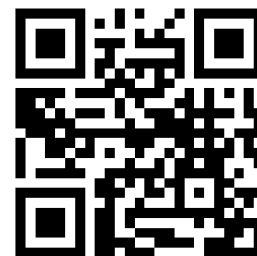
Dear Students,

6. You will receive an email with a registration number and a web link. You have to forward the link to the Email of the Nodal Officer (accantiragging@gmail.com)
7. Get a printout of the Email and submit it to the Verification Desk/respective department.
